Tarrant Elected 10th Bishop of SD

he Very Rev. John Tarrant was elected on May 9 to serve as bishop coadjutor (bishop with right of succession) of the Diocese of South Dakota.

Tarrant, 57, currently rector of Trinity Episcopal Church in Pierre, South Dakota, was chosen on the second ballot in an election held in Pierre. Out of a total of 53 clergy and 138 lay votes, Tarrant received 44 clergy votes and 101 lay votes on the last ballot. He will be the 10th bishop of South Dakota.

The other candidates were the Rev. John Floberg, the Rev. Douglas Dunn and the Rev. Peter Stebinger, who withdrew after the first ballot. Results are posted on page 6 and on the diocesan website.

"It's a weighty thing to be elected a bishop of this church. My first idea is to get out amongst the folks and listen. My style has never been to go into groups as if I had all the answers," said Tarrant in a phone interview shortly after his election.

Among the difficult issues he will be facing, he said, are social conditions at some of the 60 Episcopal congregations in the diocese located on Indian reservations. "At one, the suicide rate is epidemic and the church has to be a beacon of hope in those

situations," said Tarrant, who is not from a native background.

One of his priorities, Tarrant said, will be to visit the Pine Ridge Indian Reservation, where the current bishop, Creighton Robertson, last year closed nine churches, citing declining contributions and atten-

We learn that it is from God that we receive "life and breath and everything." And we learn that it is through God that we "live and move and have our being." May the God of peace be with us all during this in between time.

College for Bishops program was introduced in a pilot phase in the fall of 2007. This is a 90-Day Companion program for new bishops and essentially assigns a bishop companion to a newlyelected bishop to serve as a guide and/or resource person for the first 90-days after election. After the new bishop's consecration (which is typically 90 days after election), a bishop peer coach is then assigned to the new bishop for the duration of the three-year Living Our Vows program.

Bishop Frank Brookhart of the Diocese of Montana has agreed to be Bishop-Elect Tarrant's 90-Day companion.

"Sarah brings enormous energy and vision to this work and a capacity for building bridges among and between the diverse constituencies that make up our indigenous membership in the Church," said the Rev. Brian Grieves, director of the Church's Advocacy Center.

Eagle Heart has been serving as a part time consultant to Native American Ministries since October 2008. She has also been the administrator for Holy Cross Episcopal Church in Pensacola, Florida.

"As a Lakota and an Episcopalian, I try to lead by example," Eagle Heart stated in her application letter. "Communication is essential. My hope is ...

(that) I can encourage reconciliation, spiritual formation, and inspire our people into leadership for the future of absolute equality among genders, cultures and countries."

She holds an MBA in global management from the University of Phoenix, San Diego. Eagle Heart is enrolled

as a member of the Oglala Sioux Tribe in Pine Ridge, South Dakota, and was

raised on the reservation.

Eagle Heart will be based in Los Angeles, which has

the largest population of Native Americans in the United States. From the Los Angeles regional office, Eagle Heart will have access to indigenous commu-

nities in various locales, including Hawaii, Alaska, Navajoland, the Dakotas, Minnesota and Oklahoma. Additionally, she will work part of each summer on the Pine Ridge reservation.

Province VI Letter to GC

To the Bishops and Deputies of the General Convention of the Episcopal Church:
We the members of the Synod of Province VI, gathering in our Annual meeting in Bloomington, MN, prayerfully considered our participation at our next General Convention. With all due respect, we offer the following for your consideration.

We the people of the church in Province VI, Land of Mountains, Lakes and Plains, are thankful for our church and its people. We wonder if we might, as members of the church, see the harm we do to each other because of what is often seen as our need to be right, or our need to win. Perhaps this is the time when we remember the lessons of our elders: instead of answering questions, we might first ask questions; not saying, "I think this is what we should do;" but sitting and listening; and after the listening, remember that everyone is related to each other. We might remember that the establishment of honor and respect is the first item on the agenda of our "to do" list. It is simply good manners to be respectful of our neighbors in our dealings with one another.

Perhaps this is time when we don't make the mistake of behaving like we believe that silence needs to be filled. That listening can come after we have created space for listening.

We recognize that we will share conflict with each other. Perhaps, this is the time when those conflicts rise, or tensions increase, that we might consider turning around and entering into an time of fellowship. Where we might look at how we go about our disagreements, our dynamics in our disagreements, and ask ourselves, "are we being fair?" If we are saying that we recognize the face and voice of Christ in each and every person, then perhaps we might act as if we believed it.

Finally, we have the collective wisdom of scripture and our elders which says that we are connected to the earth and to each other. We have the collective wisdom of scripture and our elders which says that God is with us. We have the collective wisdom of

We have the opportunity as a church to make our life together a sign of Christ's love to this sinful and broken world, so that unity may overcome estrangement, forgiveness heal guilt, and joy conquer despair.

Tarrant involved in Crow Creek initiative

Bishop-elect John Tarrant was in Des Moines, IA at the end of May attending the Harvest Initiative board meeting. Harvest Initiative is a non-profit economic development group working specifically on Crow Creek Reservation. Fr. Tarrant was invited to join the board about four months ago, and they meet a couple times a year.

From their website:

The Harvest Initiative was organized in the spring of 2008 to create and facilitate economic activity on the Crow Creek Sioux Reservation by assisting tribal members, either individually or cooperatively, through training entrepreneurs, providing access to capital and enhanced financial literacy.

The activities of this organization focus on alleviating the effects of poverty on the reservation through the provision of financial literacy education and long term growth of the local economy. In particular, the Harvest Initiative works at the grassroots to assist tribe members in developing a native owned financial institution to meet the needs most critical to the reservation.

The Harvest Initiative resulted from a collaboration between a Des Moines, Iowa business executive and two Drake University law students. The group became involved with the reservation through the Together For Hope campaign organized by the Cooperative Baptist Fellowship and the missions and relief efforts of Ashworth Road Baptist Church in West Des Moines, Iowa.

A major milestone for The Harvest Initiative and the Crow Creek Reservation was achieved recently when

Before arriving in South Dakota, Tarrant served parishes in Western Massachusetts and Connecticut. He and his wife Patricia are the parents of a combined family of 11 grown children, one deceased. Jessica lives at home with them.

The election must be ratified by the House of Bishops and the House of Deputies at the General Convention of the Episcopal Church, set for July 8-17 in Anaheim, California. Tarrant's consecration as bishop is set for October 31 in Sioux Falls.

Many are needed to help with the service, to be led by **Presiding Bishop Katherine Jefferts Schori**, and attended by an estimated 2000 to 3000 people. **The Rev. George Parmeter** of Grace Church, Huron, has been named ceremonialist for the service, meaning he has the responsibility of organizing the liturgy according to the protocols of the national church.

"We want broad representation from the entire diocese," says Father Parmeter, "and we especially want a strong youth presence. This is a rare opportunity to be involved in a very moving, important event in the life of the Church. Those who can help are asked to submit their names as soon as possible and <u>no later than July 1</u> to Father Parmeter. All names need to be submitted far in advance to the national church, which will prepare the order of service.

- 7. Vergers

GRACE HAPPENS

"Mountains Melt Away"

n Sunday, May 18, 1952 my brother, Art, climbed Mt. St. Helens with three other University of Washington students. On the way down, Art was carrying the group's only rope when he fell into a crevasse on the north side of the mountain. Rescue efforts by those in his party and others in the area failed. By the time word was finally relayed to the Mountain Rescue Council, and they got to the mountain, it was too late; they couldn't go up until the next morning. They brought Art's body down to the lodge at Spirit Lake where my parents met them.

The funeral service was first set for Christ Church in Seattle where Art had participated as a member of Canterbury Club, but because heavy press coverage of the accident created so much interest, it was moved to St. Mark's Cathedral.

My father planned the service. He chose one hymn, but that night another tune kept running through his mind. He checked the hymnal. Two hymns were set to that tune and he found the less familiar one, words from a poem by Alexander Pope. When Dad read the last verse he knew that was the right hymn.

The seas shall waste, the skies to smoke decay, Rocks fall to dust, and mountains melt away; But fixed his word, his saving power remains; Thy realm shall last, thine own Messiah reigns.

The cathedral was packed for the service conducted by Bishops Bayne and Huston. The clergy of the diocese volunteered to be the choir. A priest later told Dad they were sur-

prised at the hymn he had chosen until they read the last verse, and then some were too moved to sing. The hymn was my father's cry of faith in the face of this tragedy. He felt the way he was guided to the hymn after he had originally chosen something else, meant the hymn was a gift from God.

Fast forward 28 years to another Sunday, May 18 in 1980. At about the same time my brother had fallen into that crevasse in 1952, the north side of Mt. St. Helens blew out in the eruption that killed 58 people and stunned the world. The glacier in which Art died melted in an instant, and a huge pyroclastic flow poured down the mountain. Rocks were pulverized into dust that rose in a cloud that would circle the earth.

My family was living in Cheney just outside Spokane and ash from the cloud fell on us that day. Amid the concern and uncertainly about how to deal with the ash, I realized the eruption had done just what the hymn had described. The part of the mountain where Art died had melted away and its rock had turned to dust exactly 28 years later.

The grief and suffering caused by this new tragedy at the mountain gave increased importance to Alexander Pope's words – "Thy realm shall last, thine own Messiah reigns." No matter what devastation occurs in this world, the final word will always belong to God.

CENTENNIAL CHALLENGE FUND 2008 ANNUAL REPORT

One loan applications was considered and approved in 2008. This was for the construction of a new church building for St. Mary's and Our Blessed Redeemer in Flandreau.

The Rosebud Episcopal Mission paid off their loan early.

As of December 31, 2008, seven loans were being repaid, with interest rates that ranged between 3.0% and 8.25%. Loan balances to be repaid total \$169,014.59.

Other assets in the Centennial Challenge Fund are invested in cash and Frank Russell Lifepoints Growth Stategy Fund – Class A. The market value of these investments was \$228,550.60.

NIOBRARA COUNCIL ACTIVITIES

The 136th Niobrara Convocation was held June 19-22, 2008 hosted by the Cheyenne River Episcopal Mission Churches at Eagle Butte, SD. The Pledge Sheets were revised and used for the first time to reflect all non-pledge items for men, women and youth. Bishop Creighton Robertson introduced The Most Reverend Katherine Jefferts Schori, the twenty-sixth Presiding Bishop of the Episcopal Church, as a special guest.

In regard to building ministry, Fr. Paul Sneve, Rev. Mercy Hobbs and Fr. Les Campbell explained their roles in providing programs to expand ministry in South Dakota and what has been planned for the Niobrara School for Ministry. Fr. Sneve spoke of Summer Seminary at Thunderhead Episcopal Center and Diocesan Ministry weekends are ongoing. Contact either Fr. Paul Sneve or Rev. Mercy Hobbs to register for classes, anyone who has an interest is urged to register and attend the classes.

The Five Year Plan for the Niobrara Deanery will consist of:

- 1. Real involvement with action steps, which includes everyone.
- 2. Record keeping for committees that could include By-Laws and the process for planning.
- Building up Lay Ministry throughout the missions.
- 4. Reaching out to the youth by developing programs and reorganizing the Niobrara Youth Council and the Young People's Fellowship.

One of the main topics was the Election of a Bishop, the roles of the Standing, Nominating and Transition Committees in the process, the Election Convention and the Consecration. A delegation from Rosebud Mission requested the 137th Niobrara Convocation be held there in 2009 which was a formality and unanimously approved. The following missions will host the Niobrara Convocation in the future: 2010 at St. Mary's Church, Old Agency, Sisseton Mission; and 2011 at St. Matthews, Rapid City. The Laity Licenses were distributed to the clergy or representatives from the mission churches to present to their members.

Several Niobrara Council meetings were held throughout the 2008-2009 year to take of business matters.

 We met August 15-16, 2008 St. Peter's Church, Ft. Pierre, SD. Pat LeBeau discussed dividing money from *Wopila* to lay readers for mileage. Standing Rock does this and Sisseton will do the 5th Sunday, all the churches will come together and divide the money. A motion was made and

- passed to transfer \$500 from *Wopila* to be used at the 137th Niobrara Convocation and divide it among the lay readers.
- The Standing Rock North Dakota representatives are recognized at the Niobrara Convocation when members attend. They requested the Natives confirmed in North Dakota be able to wear the Niobrara cross. Bishop Hare designed the cross specifically for Natives confirmed by the Episcopal clergy. This will be referred to Bishop Robertson.
- The Standing Committee recommended the Niobrara Council draft a letter to be provided to funeral directors a protocol to follow when someone dies and the family makes a request for a particular cemetery. This letter will be put on the Diocesan website in the near future.

We met at the Diocese of SD Annual Convention on October 3, 2008 Cedar Shore Resort, Oacoma, SD. Johnny Wilson commented about youth attending events, we need more media coverage sent throughout the missions. Fr. Les invited Rita Powell to speak about the Youth Ministry Council. She had a handout, Young Adult Leadership Workshop. She will submit a tentative budget to the Niobrara Council at the March meeting. There were recommendations for vacant positions on Diocesan Committees, and the registration and forms completed for submission.

The next meeting was March 27-28, 2009 at St. Peters Church, Fort Pierre, SD.

Rita Powell announced TEC has a full staff of SD college students to staff the summer sessions. She will be at Rosebud during Holy Week to meet with camp counselors and Niobrara Convocation planning committee. She anticipates the activities offered will be exciting to the youth. The goal is to promote youth ministry, her job is to find them and ask them to reach out and let them know the church is there for them and with them. Johnny Wilson had two ideas: 1) to ask if the BCU-St. Andrew will start a vegetable garden at TEC to promote an awareness of our connection to mother earth, and 2) have the youth complete an interest inventory/survey to determine what they want to learn about and do in accordance with the goals at TEC. A motion

was made and passed to give \$3,500 to the youth group, which is a matching funds challenge from the St. Mary's Board, and \$1,000 to the Sisseton lay readers conference.

- There was clarification regarding the Niobrara cross and Policy 1 was adopted by the Niobrara Council. The Niobrara Council bought the small crosses and the Diocese bought the large crosses.
- The nominees for the election of a bishop and their spouses will visit the Diocese of South Dakota April 29 through May 3, participating in a series of five forums around the state. A special election convention will be held on Saturday, May 9, 2009 at the Ramkota Convention Center in Pierre with voting delegates from each of the churches in the Diocese.
- The formation of a Province VI Native Network
 Formation Team met March 4-6, 2009 at Blue
 Cloud Abbey. A plan is in progress for the first
 Province VI Native Ministry Gathering which
 would be attended by Native clergy and Native lay
 readers ministering in Native congregations.
- Vern led a discussion of a grant proposal in regard to Niobrara Deanery, which was written two years ago and still on the books at the Diocese. He has written a new proposed New Opportunities Grant for 2009 in the amount of \$10,000.00. A cover letter from Fr. Les Campbell and Bishop Robertson is needed to submit to the Office of Native American Ministries.
- Fr. Spruhan discussed the 137th Niobrara Convocation Planning Committee report, the tentative schedule and roles of the Bishop Coadjutor and Bishop Robertson at Convocation. The planning committee will send flyers regarding the 137th Niobrara Convocation to all churches in SD. The theme is, *Let the little children come to me...* Matthew 19:14.

South Sudan Education

oses Joknhial II's dream of helping the children and adults receive an education in his na-

tive village in South Sudan is being fulfilled, thanks to the generosity and fundraising efforts of many parishioners in the Diocese of South Dakota. **Construction of the school building is well underway** with plans for the school to be completed during the next dry season (January - April, 2010).

Beginning last January, Moses spent three months in his native village implementing and overseeing his project's activities. Reuniting with his father, family, and villagers for the first time since he was forced to flee from his village and country in 1987 was celebrated for days with praises to God for his safe return.

Upon returning to Sioux Falls in April, Moses was pleased to report the school foundation has been completed and half of the concrete blocks for constructing the walls have been made. Under Moses's supervision, construction of the

school will resume in January with completion expected in April and costing \$35,000. A water well at the site of the school was completed on February 20, 2009, with funds generously provided by the community of Watertown, SD. Additional water wells are needed to serve the size of his community at \$13,000 per well. Two automated corn grinding mills have been provided through the generosity of two families and are key in helping girls attend school. A third grinding mill is being sought at a cost of \$2500.

With joyful singing, dancing, and prayers, the Christians of his community expressed their gratitude to their brothers and sisters in the United States for providing them with educational opportunities and improvements for their future. 2009 is a memorable year to them as they see hope of a better life for the first time in decades. 2009 is a memorable year for Moses as he reunited with his father and family for the first time in decades and sees his mission of helping provide a better life for his people being fulfilled.

We also express our gratitude to all of you for your support of Moses's project. Every gesture of help from you makes a world of difference to them. Please let us know if you would like additional project information or would like to have Moses visit your church, school, or service organization.

Diocesan Council

The Diocesan Council consists of the Bishop and one person elected from each Region Deanery, the Diocesan Convention, the Niobrara Convocation, the Chancellor, and the Treasurer. The Council implements actions assigned to it by the Diocesan Convention; reviews diocesan regional and local programs, administers legal functions of the Diocese; controls the property under the Chapter; determines budget policies; recommends programs, and more. It meets 4 times a year or as necessary. Council members are voting delegates to Annual Convention.

Standing Committee

- 1 Presbyter (Priest) to fill 4 year term (term expires 2013)
- 1 Presbyter (Priest) to fill 3 year term (term expires 2012)
- 1 Lay person to fill 4 year term (term expires 2013)

With a Bishop in charge of the Diocese, the Standing Committee shall be the Bishop's Council of Advice. When the Diocese is without a Bishop...the Standing Committee of the diocese shall be the Ecclesiastical Authority as provided by the General Convention Constitution and Canons. The Standing Committee also plays a part in the ordination process. The Standing Committee consists of eight members, and election shall be made by the diocesan convention for a term of four years. Members are entitled to election for two terms. The Standing Committee meets 3-4 times a year, or as needed. A member of Standing Committee is a voting delegate to Annual Convention.

Province VI Deputy

- 1 Clergy (presbyter or deacon) to fill 3 year term (term expires 2012)
- 1 Lay person to fill 2 year term (term expires 2012)
- 1 Lay person to fill 3 year term (term expires 2013)

Each Province has a Synod which meets regularly (generally yearly around the Province) for the purpose of organizing and carrying out the responsibilities of the Province. The Provincial Synod can enact ordinances for its own regulation, elect judges of the Provincial Court of Review, perform such duties as may be committed to it by the General Convention, and deal with other matters within the Province, as directed and limited by Canon. Annual Diocesan Convention elects one clerical and one lay deputy and alternates to the Provincial Synod for a term of 3 years.

Trial Court is an elected body consisting of five members (3 presbyters and 2 lay persons) for terms of five years for the trial of any priest or deacon subject to its jurisdiction. The Trial Court shall be governed by the Rules of Procedure set forth in Appendix A to the General Convention Title IV and by Federal Rules of Evidence.

Introduction to General Convention

ith few precedents for a republican form of church governance the first General Convention met in 1785 in Philadelphia. That convention began work on a constitution and a revision of the Book of Common Prayer, the church's book of worship. Within ten years the General Convention had agreed on its form of governance and its pattern of worship, both of which endure to the present day.

Uniquely for its time, the first General Conventions determined on a bicameral house in which elected (rather than royally appointed) bishops would make up one house, and lay and ordained deputies (equally represented) would make up the other house.

All bishops of the Episcopal Church, active and retired, are entitled to seat, voice and vote in the House of Bishops (unless deprived of the privilege). Each of the Episcopal Church's dioceses (and the Convocation of Churches in Europe and the Navajoland Area Mission) is entitled to elect eight deputies, four lay persons and four priests and/or deacons, to the House of Deputies. (The diocesan electors of deputies are themselves elected representatives from local parishes.) Deputies are not delegates; that is, they are not elected to represent the electing dioceses.

Deputies vote their conscience for the good of the church. They cannot be instructed to vote one way or another, for to do so would preclude godly debate and preempt the work of the Holy Spirit. Deputies are expected to serve on committees, if appointed, to attend forums and hearings, to read the reports to the church from its commissions, committees, agencies and boards, to listen to, and if so moved, to respond to resolutions on the floor of the house.

The House of Bishops and House of Deputies meet, deliberate and vote separately. To be enacted resolutions must pass both houses in the same language. Both houses have the right to amend legislation, but the amendment must be accepted by the other house. Resolutions presented to convention come from four sources: committees, commissions, agencies and boards of the church; bishops; dioceses and provinces; and deputies.

In the House of Deputies three lay or clerical deputations may request a vote by orders. In a vote by orders each diocesan deputation has two votes: one lay vote and one clerical vote. To cast that vote the deputation is polled. If a majority of a deputation is in favor, the diocesan lay or clerical vote is cast as a "yes." If a majority of a deputation is opposed, the vote is cast as a "no." Tied deputations count as "divided" and, in effect, as additional "no" votes.

The House of Bishops is chaired by the Primate of the Episcopal Church, Presiding Bishop Katharine Jefferts Schori, and, in her absence, by the Vice Chair, Bishop Richard S. O. Chang. They are assisted by the Secretary of the House of Bishops, Bishop Kenneth L. Price; a Parliamentarian, Bishop John Buchanan; and a Chair of the Committee on Dispatch, Bishop Wayne Wright.

The House of Deputies is chaired by the President of the House, Bonnie Anderson, and, in her absence, by the Vice President, The Rev. Brian Prior. They are assisted by the Secretary of the House of Deputies (myself); a Parliamentarian, Polly Getz.

Much of the work of convention is carried out by legislative committees. The Presiding Bishop and the President of the House of Deputies determine the number of persons who serve on committees and their membership. Deputies are asked to indicate their preference for membership on committees, and the presiding officers make their choice considering previous experience, expertise and interest, ensuring the committees represent diverse points of view, geographic, ethnic and gender diversity and participation by younger deputies.

Resolutions proposed for discussion at convention are referred to legislative committees, which consider, amalgamate and perfect them before presenting them on the floor of convention. Legislative committees hold hearings on legislation at which the following can speak: deputy, registered alternate or registered visitor. These are held in convention hotels near the Convention Center.

In 2009, the 76th General Convention of the Episcopal Church will meet in Anaheim, California from Wednesday, 8 July through Friday, 17 July. General Convention meets prayerfully. Each day

bishops, deputies, registered alternates and delegates to the ECW Triennial gather for Bible study and Holy Eucharist. At this year's General Convention the themes for these gatherings will reflect the theme of General Convention: Ubuntu.

Both the House of Deputies and the House of Bishops have chaplains, who lead their houses in regular prayer at the beginning and end of sessions and daily at noon. Chaplains are also asked to pray before the enactment of important legislation. Organizations within the church sponsor additional worship services, while volunteers staff a prayer room in which there is continual intercession for the work of convention.

A highlight of every General Convention is its festival Eucharist at which the United Thank Offering is presented. (The United Thank Offering is taken up in parishes twice each year for the mission of the church.)

Debate on the floor is governed by the Constitution and Canons of the church, Rules of Order for each house, Joint Rules of Order (that apply to both houses) and Roberts' Rules of Order. Deputies are expected to listen respectfully to the views of others and to adhere to the rules, which require, for example, that persons of different points of view alternate at microphones.

Convention is more than legislation. One of the most interesting parts of convention is the Exhibit Hall. The Exhibit Hall reminds me of an oriental souk: it is a marketplace of goods and ideas in which the organizations and interest groups within the church present their wares, recruit members and do their best to influence legislation. It is a colorful part of convention, and it would not be General Convention without it.

Many church-related organizations hold meetings in conjunction with convention, and there are lunches and dinners hosted by seminaries, provinces, societies, boards and staff offices of the church. One gathering not to be missed is the triennial meeting of the Episcopal Church Women. The ECW meeting has changed over the past several decades; it focuses on the mission and service of the church, and many of the church's most distinguished members are invited

to address this body.

General Convention is a combination of legislative assembly, bazaar of goods and services and family reunion. It is one of the most exciting and, truth be told, one of the most awe-inspiring gatherings in the world.

Innovative Media Hub provides round-the-clock look at General Convention 2009

You will be able to follow, watch, understand, experience and enjoy the Episcopal Church's General Convention 2009 no matter where you are, thanks to an innovative addition to this year's event, the Media Hub.

Produced and presented by the Episcopal Church Office of Communication, the Media Hub will utilize cutting edge technology including videos, blogging, twitter, flickr, and live webcasting to deliver the full story in real time.

The Media Hub

Seven distinct areas will be featured on the Media Hub: calendar, video stream, flickr photos, activity area, legislative tracker, twitter feed, and resources.

- A complete calendar of events detailing the daily GC09 schedule as well as special events during both the day and evening hours. On each item in the calendar there will be an icon to indicate if the event will be covered live, or if video on-demand is available.
- 2. The largest area will be the **live video stream** of many wide-reaching events occurring at GC09, such as briefings, legislative hearings, and special events. The live stream will vary every day but the programming will all be listed in the calendar. There will also be a library of videos ondemand, including all the sermons presented at the Daily Eucharists.
- 3. The **flickr** gallery of photos will feature continually updated snapshots of the widespread aspects of life GC09. Deputies, alternates, bishops and visitors will be able to easily upload their own photos to this site at the Church Center booth in the exhibit hall.



- 4. The Activity area will aggregate content that is relative to GC09 from a wide array of sources, including Episcopal News Service; articles from diocesan publications, religious and secular press; comments from people on Twitter and Facebook; and other sources.
- 5. The **legislative tracker** will enable viewers to follow the life of a resolution and ties directly into the actions and votes of GC09 through the GC database.
- 6. Media Hub's **twitter** feed will be a source for quick announcements—a way of letting people

- know offsite or in the hall when an event is about to begin, if a room has changed, when something goes live.
- 7. The **resource section** will list links to maps, things to do in Anaheim, directions, and other information.

The Media Hub will go live shortly before General Convention, tentatively July 1.

Hunkpati Investments, Inc. was formally created to become a certified Native Community Development Financial Institution (NCDFI) which will serve the Crow Creek Reservation market. Assisting with the creation of a NCDFI is one of the central purposes of The Harvest Initiative and the creation of Hunkpati Investments is a big step down that path.

Hunkpati Investments currently has an eight member board of directors which is developing the programs and policies that will be the economic development tools used by the organization. Seven of the eight board members are Native American and five of the board members reside on the Crow Creek Reservation. The institution is still being developed, but products are likely to include financial literacy offerings for both adults and youth. Loan products are also being developed.

The Harvest Initiative will continue to provide support and assistance to Hunkpati Investments, Inc. as it develops in the form of consultation services, networking, administrative support, and capitalization assistance.

The Harvest Initiative was founded in 2008 to invest locally in native grown ideas and support socially responsible business development to move Crow Creek Sioux Reservation toward a commercially viable, selfsustaining economic environment.
