"Then Jesus, knowing all that was to happen to him, came forward and asked them, 'Whom are you looking for?" (John 18:4). In John's Gospel, everything Jesus has experienced has led him to this climactic moment just before his arrest. In our search for the 11th Bishop of South Dakota, we're not yet at the moment where we can ask 'whom are you looking for?', but our search process is leading us toward that climactic moment in the next stage of our communal life as Episcopalians in South Dakota. It's an exciting time.

The Search/Nominating Committee met on May 26th in Pierre to finalize the questions used for the diocesan-wide survey. The Committee is deeply grateful for the 300+ individuals who took the time to complete the survey either online or on paper. We are especially grateful for the quick work of diocesan staff members Dr. Chris Corbin for posting the survey online and Marlys Fratzke who worked extra hard to get the paper copies completed in time for distribution at the Niobrara Convocation.

The surveys were evaluated and summarized to assist in developing deeper questions for the diocesan-wide Listening Circles held in each deanery. The Committee appreciates the helpful work of the Deanery Conveners who facilitated the Listening Circles across our area as well as all those who took the time to attend and share their thoughts, feelings, hopes, and dreams as we evaluate the Episcopal Church's future in South Dakota. There's been much positive energy flowing in and through the various Listening Circles, calling to mind Jesus' words to his nervous disciples, "For it will not be you who speak but the Spirit of the Father speaking through you" (Matthew 10:20).

As the Holy Spirit has spoken through those who have participated in the surveys and Listening Circles, the Search/Nominating Committee will use the thoughts, feelings, and insights of our Siblings in Christ to formulate a Diocesan Profile. The Profile is scheduled to be released on

Description of possible positions open for election at Diocesan Convention.

September 28 & 29, 2018 at the 1st United Methodist Church in Pierre.

It is the usual course of business for delegates to vote on nominees to fill various positions.

Standing Committee—1 lay person Standing Committee—1 clergy (priest or deacon)

Convention Representative to the Diocesan Council

Convention Representative is a person elected by the body of the Convention, who will attend Diocesan Council meetings giving voice, vote and representation on behalf of the convention

Standing Committee

With a Bishop in charge of the Diocese, the Standing Committee shall be the Bishop's Council of Advice. When the Diocese is without a Bishop...the Standing Committee of the diocese shall be the Ecclesiastical Authority as provided by the General Convention Constitution and Canons. The Standing Committee also plays a part in the ordination process and deals with certain property issues.

The Standing Committee consists of eight members, and election shall be made by the diocesan convention for a term of four years. Members are entitled to election for two terms. The Standing Committee meets 3-4 times a year, or as needed.

A member of Standing Committee is a voting delegate to Annual Convention. A member of Standing Committee is also a member of the Title IV Ecclesiastical Disciplinary Board.

Resolutions to Diocesan Convention

All Resolutions to Diocesan Convention are to be submitted in writing to the Committee on Resolutions through the Diocesan Office. They should be clearly typed. The committee requests that resolutions do not begin with "whereas" but simply state the resolution, followed by the explanation and rationale. The "whereas" is not part of the resolution. This format for resolutions allows for greater clarity as to what the resolution is attempting to communicate.

Resolutions should take the following form.

Submitted by (name of individual, church, or deanery).

RESOLVED, that the One Hundred Thirtythird Convention of the Diocese of South Dakota (state the resolution).

RESOLVED (Further resolves may also be stated).

Explanation: (This is where informative material and rationale for the resolution is inserted. It is used in place of "whereas")

Impact on Budget: (This is where an estimate of costs is placed and suggestions for funding)

***The deadline for submitting resolutions generated before the pre-Convention deanery meeting is one week before those meetings and the deadline for submitting resolutions generated at pre-Convention deanery meetings is no later than the Friday following those meetings.

According to Rules of Order, Rule number 6.1

No proposed resolution may be submitted for consideration after the close of the first plenary session. All proposed resolutions shall be referred to a Convention committee by the Chair, in consultation with the Dispatch of Business Committee. Such reference may be appealed in the same manner as a procedural decision of the chair.

There must be an opportunity for a hearing on any resolution, other than a courtesy resolution, before it will be brought before the whole body of the convention.

Episcopal News Service – Austin, Texas] The voices and stories of women played a significant role in the workings of the 79th General Convention, from a <u>liturgy</u> where bishops offered laments and confession for the church's role in sexual harassment, exploitation and abuse, to <u>Resolution D087</u> that allows deputies to bring infant children on the floor of the House of Deputies to feed them.

On the night of July 4, before the convention officially opened, a Liturgy of Listening featured stories from women and men who were victims of sexual misconduct perpetrated by someone in the church. Bishop DeDe Duncan-Probe of the Diocese of Central New York, who planned the service, said it was designed to help set a framework for General Convention's consideration of resolutions dealing with sexual misconduct, exploitation and gender disparity. As part of a response to that liturgy, the House of Bishops on July 8 adopted a <u>covenant</u> that commits them to seek changes in their dioceses to combat abuse, harassment and exploitation. The document, which applies only to bishops, is entitled "A Working Covenant for the Practice of Equity and Justice for All in The Episcopal Church." Bishop Mary Gray-Reeves of the Diocese of El Camino Real said the covenant grew out of the Liturgy of Listening because it was clear that "there is no way we can do this and nothing more." She said, "Sexual abuse, harassment and exploitation are part of the system. This is about acknowledging and accepting that."

Special House of Deputies committee offered resolutions

In February, the Rev. Gay Clark Jennings, president of the House of Deputies, appointed a 47-member special committee to draft proposed legislation on sexual harassment and exploitation. This followed a <u>letter</u> to the Episcopal Church in January from Presiding Bishop Michael Curry and Jennings, calling for the church to "examine its history and come to a fuller understanding of how it has handled or mishandled cases of sexual harassment, exploitation and abuse through the years."

The special committee, sometimes dubbed the "MeToo Committee," proposed more than two dozen resolutions on topics ranging from changes to the canons on clergy discipline to issues of clergy compensation and pension equity for lay employees. Other resolutions touching on issues of gendered language and clergy employment were proposed by deputies from outside the committee. The convention adopted many of the proposals.

Changes to Title IV canons on clergy discipline:

- <u>D034</u> eliminates the statute of limitations for victims of clergy sexual misconduct for three years between Jan 1, 2019 and Dec. 31, 2021.
- <u>D074</u> amends the start of the process for filing charges.
- <u>D076</u> protects people who file charges against a member of the clergy from retaliation and allows confidential filings for those who fear retaliation.

Several resolutions dealt with changes to structures inside the church:

- <u>D016</u> creates a Task Force on Women, Truth and Reconciliation to help the church "engage in truth-telling, confession, and reconciliation regarding gender-based discrimination, harass ment and violence against women and girls."
- <u>D021</u> removes from the materials that clergy file with the Office of Transition Ministry any refer ence to gender or current compensation, since statistics show women in the church are paid

less than men of comparable experience.

- <u>D022</u> creates a task force to track resolutions from this convention that relate to challenges of women in ministry and to report findings twice a year to the Executive Council.
- <u>D025</u> creates a task force on clergy formation and continuing education, especially regarding preparation for ordination.
- <u>D026</u> adds family status, including pregnancy or child care plans, to the list of things for which no one in the church can be denied rights, status or access to an equal place in the life, worship, governance *or employment of the church*.
- <u>D037</u> directs the Church Pension Group to expand its Clergy Compensation Report to include more specifics on items relating to gender.
- <u>D045</u> affirms that pension plans for clergy and lay employees need to be more equitable and calls on the Church Pension Group to study how to make that happen.
- <u>D046</u> continues reauthorizing the expansive-language rites in the Enriching Our Worship series and calls on the Standing Commission on Liturgy and Music to create principles to use in developing additional expansive-language liturgical texts.
- <u>D067</u> encourages the use of inclusive and expansive language for God and humanity, offering examples of how to do that based on the stylebook of the Society of Biblical Literature.

Addressing the needs of women in society:

- <u>A178</u> calls for a halt to inhumane and unjust immigration policies that are harmful to migrant women, parents and children.
- <u>D017</u> calls for policies that reduce sexual harassment, assault and exploitation in the workplace.
- <u>D031</u> encourages clergy and congregations to educate themselves on resources to combat and deal with domestic violence.
- **<u>D032</u>** advocates for equal access to quality health care regardless of gender.

A thankful committee

The Rev. Laurie M. Brock, deputy from Lexington, Brock thanked Jennings "for recognizing that as Christians we have the responsibility to respond to the plight and exploitation of women and all who are victims of abuses of power in this culture." "Thank you for giving this house and the House of Bishops a way to engage in the holy work of reconciliation and of love. Thank you for helping us all magnify the Lord and filling those who were hungry for good things of equality, of justice, of safety and, most importantly, of love," Brock said.

While the House of Bishops is overwhelming male, 53 percent of the deputies to this General Convention are women. That is just slightly lower than the Episcopal Church as a whole, which according to 2014 statistics, is 55 percent women. *Melodie Woerman is director of communications for the Diocese of Kansas and is a member of the ENS General Convention reporting team.*

 - The Rev. Canon David Hussey will retire at the end of October when he reaches 72.
- 7. Clergy deaths since last convention:
 - The Rev. Lyle Martin died last June.
 - The Rev. Charles Thayer from Sioux Falls died this late spring.
 - The Rev. Charles King, living in Connecticut, died this past July.
- 8. A motion was made by Conrad Ciesel and seconded by Portia Corbin to give both voice and vote to the Rev. Charley Chan, Sisseton Mission; the Rev. Daryl Schubert, St. Mary's Mitchell; the Rev. Henrique Fleming, St. Matthew's, Rapid City. Motioned approved.
- 9. The Minutes from last year's Convention were printed in the *Church News*. Annie Henninger moved and Nyle Hedin seconded that the minutes be accepted as printed. Motion approved. The convention reports from different commissions and committees also were printed in the Church News. Nyle Hedin moves and Charles Walker seconded that these reports be accepted. Mo tioned approved.
- 10. An overview of the schedule was given.

This year we have four workshops

Gladys Hawk is ill, so we won't have the Lakota stories. Please tell her she was missed.

<u>Chris Clem</u> will offer a workshop: "The Forever and Ever Amen", investments, endowment and memorial funds for congregations. He has been involved in this for years, and will outline ways to help develop strategies that will serve congregations generations to come.

<u>Chris Roussell</u> will offer a workshop on the Death with Dignity initiated measure to be voted on in November 2018. That will be in Amphitheater 1 - that will give you a chance to learn about this measure, so that when it comes around next year, you will be informed.

<u>The bishop and David Hussey</u> will offer a workshop on stewardship in mission congregations. We want to offer some stewardship strategies for small mission churches. We will have a Crea tion Care workshop as well.

The deadline for the submission of any nominations is before the beginning of the Opening Eucharist.

Following the service, the tabulation ballots committee - Pat LeBeau and his assistants - will meet in convention office. Tonight's offering will go to hurricane relief; many of our brothers and

sisters in Texas, Louisiana, Florida, and Puerto Rico. This is an opportunity for us, who have been blessed, to be a blessing to them.

Convention presentations:

The Rev. Benjamin Thomas, from the St. Francis Foundation, speaking to Convention: You may have wondered who I am. I am Director of Church Relations for the St. Francis Foundation, which serves 15,000 children and families every year in five states and two foreign countries. We provide hope and healing to children and families in three ways: 1) We provide care for children and families in crisis (families falling apart because of addiction, etc.) We help with foster care and adoption. 2) We offer care for adults with cognitive difficulties at our facility in Mississippi. 3) Our newest service is Clover House. Clover House is for girls who have endured trauma from sex trafficking. We do a lot of work with education on human trafficking, particularly in Central America in the areas of poverty and domestic violence My father-in-law lives in Madison. I am outside at the booth. Stop by and we can talk about how we can partner and I will answer any questions you have about the St. Francis Foundation.

The Rev. Richard Zephier, representatives from Standing Rock and Sisseton Missions along with the Bishop honored Fr. Les Campbell with a beaded Lakota stole. Fr. Les Campbell is being honored for 41 years of ordained ministry, much of it in the Diocese of South Dakota. We want him to know that he's a blessing to the Church and that we are grateful for his faithfulness. He receives a standing ovation.

Sandy Magnavito, Chairperson of the ECW scholarship committee: Last year there were no applications. This year we had four, thanks to Marlys and pushing the information out in the newsletter and emails. With the money from last year's fund - \$1,500 - we gave \$3,000 to four people, all of whom are well qualified, are active in their churches, and are supported by their churches: Amber Allen from Emmanuel, Rapid City; Valerie Regina Two Hearts, from St. James, Enemy Swim, Sisseton; Haley Foster, from Emmanuel, Rapid City; and Shelby Constant, from All Angels, Spearfish.

A second scholarship fund is, the St. Mary's Scholarship. There is \$500 available from this fund per applicant. This scholarship be open to anyone in the Diocese seeking higher education. All you have to do is be an Episcopalian in good standing and submit your transcript with letter of application to Randy Barnhardt. He forwards the information to the St. Mary's board who do the actual granting.

Presentation on disaster preparedness from Deacon Tom Regan:

There is a booth with handouts for everyone. There is one on individual family preparedness. There is a list of resources available in the state of South Dakota for getting in touch with emergency managers, county and reservations, with phone numbers. You are encouraged to make contact and let them know who you are and what resources you have to share in event of a disaster. They are always looking for other resources.

There is other material as well. Please, take those resources with you. We are encouraging every congregation to find at least one individual who can network in the event of a disaster in various regions. Please, work with Paul Sneve on populating the Asset Map. That lists within the lager Episcopal Church the network of assets available in our diocese in order to help with emergency situations. There are regular webinars through Episcopal Relief and Development. I hope to have someone speak to us next year. Everyone should have a ready bag of some kind. This afternoon, I was just about asleep when the lights went out. At first it was fine and quiet, then I thought, 'What else is out?' I cruised around town to check out the power failure. It was a construction interruption

of power in the entire west end of Pierre. You just don't know. These things happen in a heartbeat. We owe it to ourselves and our congregations to be prepared in simple way. Those suggestions are on the table for you.

Other announcements: There are several tables out in the hall. There are items for sale and a table for giveaways. BCU has a table. Also, on your tables you have UTO boxes. Please make sure as you are feeling thankful to put money in your boxes. UTO has been an incredible blessing to this Diocese. We can say, "thank you" by putting something in the boxes. There is one announcement: Registration folks have run out of packets. They will have more packets before the opening session.

We will take a recess so we can prepare for the Eucharist Service. The service will start in about 10 minutes.

Announcements:

- 1. Linda Simon: St. Mark's, Aberdeen, has a sewing group that makes comfort quilts, for people in nursing homes, sick, end of life, new beginnings, baptisms, confirmation. This year was not good for us. Three of our quilter past on the last year. That leaves us three quilters. But all is not lost: My great-granddaughter at age 5 is learning. Father Charlie says there's a group in one of his churches; we will try to get together with them. We are carrying on. I did bring some quilts. Just come out and tell us who they are for. Thank you!
 - 2. Lisa Kautz: UTO coordinator. UTO boxes on tables. We do accept bills. I will collect them at the end of the day.
 - 3. The Rev. Pat White Horse-Carda had to leave for a wedding.

Carol Cloud Eagle reported that she went to visit Don Metcalf recently. He's doing really well, sends his love to everyone, and claims he's going to slow down.

This morning before I came here, got a call, our grandson Travis was in a car accident, and is in surgery. He has breaks and fractures in his legs. The initial reports are that he is mendable, but it will be some time possibly six months in rehab. Please keep our grandson Travis in your prayers. We all have lives beyond the work we do in the church - larger lives out in the world. Be kind to those you meet; you never know what road they are walking, often by themselves. Please keep Travis in your prayers.

1. Credentials Committee: Marty Garwood

Lay Delegates: 138 are registered, 101 are in attendance. Clergy Delegates, 45 are registered, 35 are here. We have a quorum in both orders.

- 2. Report of the parliamentarian: See printed comments.
- 3. Budget Presentation by Chris Clem, Treasurer of the Diocese.

 Treasurer, Chris Clem gives narrative presentation to the financial reports and the 2018 Diocesan budget. The actual reports are part of the minutes.

Congregational support is level. Much of the rest of the income is the same. There is about \$27,000 less in expense and revenue for the year. By percentage, about 20% of income comes from individual congregations. 15 percent from our endowment. Almost 50% comes from the General Convention Block Grant that we receive to support the mission work we do in South Dakota on behalf of the larger Church. Opportunity for questions in given. Jean Lacher moves, Sandy Magnavito seconds to accept the reports as presented. Unanimous approval.

Presentation to Bishop Michael Smith: Even though Father Chan said to say this is from the Diocese, it's from the Sisseton Mission. These are some munchies for the road, and Fr. Chan wanted to share his honey with you.

Election Report: Pat LeBeau "Mr. President, pursuant to Rule of Order 7.3 of this Convention, there being only one nominee for the Office of the Clergy position and the Lay position of the Standing Committee, and of the clergy position on the Diocesan Council, the Secretary shall cast a unanimous ballot for The Rev. Hal Weidman, St. Andrew's, Rapid City for the four-year clergy position of the Standing Committee; Tamara Fonder, Standing Rock Mission, for the four-year lay position of the Standing Committee; and The Rev. Kim Fonder, Standing Rock Mission, for the four-year clergy position on the Diocesan Council."

Bishop: So ordered.

Resolutions Committee. Mikayla Dunfee and Don Eagle.

Mikayla Dunfee: I come to you from the Cheyenne River Mission. Let me briefly present the first resolution on **Creation Care** and invite those who submitted it to speak if they wish. (Reads the resolution.) It has been moved by the committee, seconded by Jean Lacher. Carol Smith, Christ Church, Yankton: We felt that this resolution was a good idea because we believe that there are several resources that the Episcopal Church has in supporting the use of some of the materials to incorporate creation care into your ministries. One of the things is that resolution would help congregations do so. There are so many things that you can do. We encourage folks to explore the resources. Maybe this resolution would help with highlighting and encouraging activities in your congregations.

Chuck Berry from St. Paul's Church in Brookings is recognized: I am the author of this resolution. We are growing this network and want to bring forward and put in the spotlight some good resources from the Episcopal Church that can help some dioceses and congregations bring creation care into the educational activities of a congregation. We are going to have a workshop today on this. All the materials are free. There is a huge amount of material for anyone who wants to learn about creation care as an obligation of stewardship by a religious community. This is our resolution and this is our story.

Vote taken, the resolution passes.

Don Eagle: (Greetings) I bring to you the resolution amending the Constitution of the Diocese of South Dakota, second reading. (Reads the resolution.) It has been moved by the Committee and doesn't need a second. It needs to be approved as presented: otherwise, if it is

changed, we will need to bring those changes to next year's convention. After hearing no questions, the vote was taken. The motion passes.

Revision of the Canons prepared by Chancellor, Steve Sandford are presented. Don Eagle: "Mr. President, I offer a resolution to totally replace the canons of the Diocese of South Dakota as printed in your white pamphlets." The Committee moves their adoption.

Canons can be changed at one convention. If we have questions and the committee or I can't answer, we can get the Chancellor on the phone. He knows we are having this conversation. A table of contents will be added.

Bishop: It has been moved by the committee and does not require a second. The canons that are in the packet replace the existing canons of the Diocese of South Dakota. Steve's objective was to re-organize and simplify these canons, re-order them, make them conform to what we actually do. There are minor changes and we improved the numbering system. We did not touch the disciplinary canon because we revised it several years ago. It is important to know that the canon that calls for the functioning of the Niobrara Deanery has not been changed. That will be a project for the Niobrara Council.

Hal Weidman, St. Andrew's Rapid, "I have an amendment to section 4.7 is not consistent with section 4.3. 4.7 starts at bottom of page 5, carries over to page 6. 4.3 is on page 5. It deals with Diocesan Council. I move to replace the word "vice chair" in 4.7 with "chancellor" as listed as an officer in 4.3."

Moved. Seconded by Fr. Chris Rousseau.

Following no discussion, vote taken, motion passes.

Father Charlie Chan, Sisseton Mission. "On page 22, 15.4.2 reads that services must be held by the vicar, deacon or worship leader not less than once each month. My amendment: "Services must be held on Sundays by the vicar, a deacon assigned or a worship leader; with the permission of the Bishop for pastoral concerns, a congregation may meet for worship not less than once each month."

Bishop suggests that the wording be changed to "Saturday/Sunday" to cover those who worship on Saturday night. Fr. Chan accepts the friendly suggestion.

Fr. Chan moves, Deanna Stands seconds.

Following no further discussion, vote taken, motion passes.

Are there any other questions, concerns, thoughts on the canons? Following no further discussion, vote taken, motion passes.

Thank you very much. We are so blessed to have Steve Sanford as the chancellor of this diocese and part of the vote today represents your confidence in our chancellor. I will let him know.

Bishop: I would like to offer a courtesy resolution to offer the greetings of the 133rd Convention of the Diocese of South Dakota to Ann Robertson, widow of Creighton; Marilyn Jones, widow of Walter; and to Craig and Liz Anderson. (Moved and seconded. Approved.) It is good to let folks know that we are thinking about them.

Bishop calls on Portia Corbin for her report on Thunderhead Episcopal Camp. Written report attached to minutes.

Portia has moved to Christ Church in Lead to serve as the vicar of that congregation. Part of this move is to bring her closer to the camp. We hope this will help congregations use the facility after camp season. This will stretch the gift of that ministry. Please keep that in mind. It's a great facility.

Canon David Hussey is recognized. David has been my canon to the ordinary for the eight years I have served as bishop. He is a friend and colleague. There is a mandatory retirement age of 72. David will reach that in the middle of October. He will formally retire at the end of October. He will serve as the interim superintending presbyter of Mni Sose and continue at St. Peter's in Ft. Pierre. I want to thank him for his faithful service. At then end of the month, the staff will gather in Pierre and take him to dinner as an appreciation.

David Hussey: "Thank you. In 1995, my wife, Mercy, and I graduated from seminary and she brought me home to South Dakota. Over the years when I have shared stories with friends and colleagues from around the nation, I tell stories about how beautiful South Dakota is. The camping, fishing, hunting, parks - everything. They are awestruck. About the one thing I can't emphasize enough, the best part of South Dakota is not the scenery, the hunting, the fishing - not even the churches. It's you, the people. You are the finest people. I was a stranger and you took me in. It has been an honor and a privilege. Mercy and I intend to spent the rest of our lives here I want to thank you for the honor and privilege of being part of your lives in South Dakota."

Announcements:

The quilt for sale from the Sisseton Mission includes pillowcase and pillow. Grace Church, Madison is selling raffle tickets for a quilt. The money will go to restore their stained-glass windows. Please recycle your red and green cards. Before you leave for workshops, take everything with you. Thank you to all the churches that donated quilts for the permanent display.

Missioner of Support: Report to the 2018 Diocesan Convention: Since last Convention, I've:

Offered several months of supply coverage at Trinity: , Watertown, including their Christmas Eve 2017 service. I am excited to see their lay-led outreach initiatives and the arrival of their new Vicar, The Rev. Isaiah Brokenleg.

Continued to provide a diocesan liaison with the Dinka congregation at Holy Apostles, Sioux Falls. I've aimed for monthly attendance but that's not always been possible - still, I've managed to get to a Sunday service there most months (have preached and led a Dinka hymn thanks to the help of Deacon John Mayan and the generosity of Fr. Abraham Mayom) and have met with the clergy and lay leaders to help them navigate some governance and administrative issues.

Continued to serve as intake for online registration for Safeguarding God's Children. Congregational participation in the abuse prevention/detection program remains hit and miss, with some congregations getting teams of people trained and others not as active. I encourage congregational leaders to look into the program as it has training components that might be useful in a number of settings beyond the traditional Sunday School and Youth Group, such as preventing Elder Abuse, protection of people with Special Needs and other possibilities for extending safety and dignity in the church and in the world around us.

Helped re-start the Diocesan Facebook page and was blessed by Chris Corbin's nationally recognized revitalization of our diocesan social media.

Am presently serving as interim Rector at Christ, Yankton, in support of their Rector search (goal is new Rector call by spring/summer 2019).

I'm grateful for the opportunity to serve with Bishop Tarrant and his team and blessed by the welcome and work I've experienced in several congregations of this diocese.

Commission on Ministry's Report to the 2018 Diocesan Convention

The Commission on Ministry has met twice during the past year. We met briefly during the 2017 Diocesan convention but had no recommendations to consider. COM'S second meeting was held April 20th, 2018. At that meeting, we recommended one person for ordination to the permanent diaconate and one for the ordination to the transitional diaconate. One person was recommended for ordination to the priesthood and two people were recommended for postulancy. Both will be attending seminary in the fall. Finally, we recommended one person for candidacy who is seeking ordination to the permanent diaconate.

The Bishop met with the COM in April and reviewed the terms for COM members. All terms expire at the end of a calendar year. Terms that expired at the end of 2017 are Carol Cloud Eagle, Shirley Crane, and Linda Simon. All agreed to serve another 4 year term which will expire December 2021.

Two year terms that expired at the end of 2017 are Michael Johnson and Jean Mornard. They have agreed to serve another 2 year term which will expire at the end of 2019.

At the end of 2018, the terms of Judy Flagstad, Barbee Hovelson and Barb Simpson will expire.

Also serving on the COM, is the Ven. Paul Sneve who is the Bishop's liaison.

Two members have resigned from the COM this year – Dottie LeBeau and the Rev. Portia Hurney. We thank them both for their invaluable work during their years of service on the commission. Both will be greatly missed.

The final business of the April meeting was assigning a COM advocate to each of the people in the process to help them manage the process and keep them on track.

For the Commission on Ministry Judy Flagstad

Transition: Last year I began working as the transition officer for the Diocese, meaning that I work with clergy seeking to serve in South Dakota and help faith communities going through search processes. In this role, I have also taken a more active interest in congregational development, helping faith communities to refine their missions and visions to be the most faithful witnesses possible to God's restorative work in their communities. This last year the Diocese has worked with Trinity, Watertown, and we are excited to announce that the Rev. Isaiah Brokenleg was called as Vicar and began work there on July 3rd, 2018. We are also excited that the Rev. Jim Marrs began a full-time position on Cheyenne River Reservation on August 1, 2018. Both St. Andrew's in Rapid City and St. Luke's in Hot Springs have begun working with me to collaboratively clarify their missions and visions and become more present in their communities. Furthermore, after looking at the transition policies of several dioceses including Nebraska and Maryland, I have begun developing a standard policy and process for congregations and communities in transition and searching for new clergy.

Communications: Starting in February 2018, I took on the role of Communications Director for the Diocese. Most of my work has involved expanding and enriching our social media presence, which has proven an unprecedented success. We have increased our Facebook page following from under 50 to over 500 (and growing) as well as starting Twitter, Instagram, and YouTube accounts. This work has included posting the Daily Office readings and daily Diocesan Cycle of Prayer, Facebook photo caption contests, Twitter book giveaways, and updates from around the Diocese. Because of my connection with Niobrara School for Ministry, we have also begun offering more online seminars (including three on using Social Media in your congregations), #DefiningFaith—an initiative to make academic theological terms more accessible, and several instructional videos through YouTube and Facebook. As we continue to expand our Social Media presence, we hope that people around the Diocese will let us know what content they would like to see. If you have not done so already, like our Facebook page (The Episcopal Diocese of South Dakota), follow us on Twitter (@DioceseSD), and follow us on Instagram (@episcopalchurchsd).

Discernment and Niobrara School for Ministry: The biggest thing happening in the world of discernment and ministerial formation in the Diocese of South Dakota is the Catechist training program. The inaugural seven-person class of Catechists began the first year-long training this last July. Together they will go through a program to equip them to better exercise a ministry of preaching, teaching, helping to administer the sacraments, and providing pastoral care and evangelism. This training program, which includes a collaborative group project, monthly group gatherings, and individual study, has been developed specifically and explicitly for the unique needs of our Diocese and is called Transformed by God's Story. Those who successfully complete the first year of training will primarily help to relieve the ministry needs of our extremely hard-working mission clergy. Furthermore, those in this first class of participants will help to refine the training curriculum so that we can continue offering this training for the foreseeable future in our Diocese and so that our Diocese can offer this desperately needed and innovative training program to the larger Episcopal Church.

However, while the diocesan focus this year is on the development and support of the Catechist training program, we have not neglected other aspects of ministry development and formation. We have issued a new revision of the Ministry Handbook which includes a distinct three-year local training program for deacons. We have continued to see great successes with our annual discernment retreats. Finally, we had one person finish the formal local discernment and education process and be ordained to the priesthood this year, we have two people from our Diocese beginning seminary this year as they discern calls to the priesthood (one going to Virginia Theological Seminary and one to Berkeley Divinity School at Yale), and we have four additional people continuing in the formal discernment process right now.

- The Standing Committee met 10/21/2017 at Trinity Church, Pierre, SD. Bishop John Tarrant gave the opening prayer. He read a letter written by him calling for the election of a bishop in South Dakota. He explained Bishop Todd Ousley's role representing the Office of Pastoral Development and the election of a bishop. A consultant will be named from the Office of Pastoral Development, after the bishop sends his email to the public. Search and Transition Committees will be assembled from names submitted by the Standing Committee.
- The Standing Committee met 02/16-17/2018 at Trinity Church, Pierre, SD. Bishop John Tarrant introduced a guest, The Rev. Thaddeus A. Bennett. This Initial Retreat is specifically for the Bishop Election Process involving The Rev. Thaddeus A. Bennett, Consultant, the Standing Committee and the Search/Nominating Committee.
- The Standing Committee held a teleconference call 05/08/2018. President Stanley reported and gave an update on the Search Process for the 11th Bishop of the Diocese of South Dakota and is going as well as it can.
- The Standing Committee held a teleconference call 06/12/2018. The Standing Committee members submitted their votes to President Stanley and it was recommended taking into consideration the chairman of the committee needs to be someone who can do the work required. The votes are to be submitted to President Stanley by June 26, 2018 and release the information to us.
- The Standing Committee held a teleconference call 06/27/2018. President Stanley tabulated the results of the voting for the Transition Committee. President Stanley asked that each nominee be contacted by Friday, 29 June. If anyone says no, she will send out the next list of nominees who received two votes for Standing Committee members to vote on. President Stanley asked that each nominee be told about the Transition Committee meeting with the consultant on Saturday, August 4, 2018 in Pierre.

We have ad snake & bat problems to deal with in a few of our units and fire loss.


We have put on some metal roofs, built some ramps, painted some buildings, fixed fences and sis some remodeling work on some of our rectories.

[Episcopal News Service – Austin, Texas] General Convention addressed some 18 resolutions further strengthening its position on stewardship of the environment and creation care, sending a message of engagement to Episcopalians churchwide.

"The number of care of creation resolutions that passed General Convention 79 was remarkable and a sign of a growing, vital spirit in the Episcopal Church around creation care," said California Bishop Marc Andrus, a member of the Environmental Stewardship and Care of Creation Committee and co-chair of the Advisory Council on the Stewardship of Creation, in a statement emailed to Episcopal News Service.

Several creation care resolutions, including A018, addressed Episcopalians' participation in the Paris Agreement. The Paris Agreement calls on the countries of the world to limit carbon emissions voluntarily, which will require a decrease in dependence on fossil fuels in favor of renewable energy sources; and for developed countries, those responsible for the majority of emissions both historically and at present, to commit to \$100 billion in development aid annually by 2020 to developing countries.

By addressing participation in the Paris Agreement, the Episcopal Church joined the We Are Still In movement.

"We said we valued our participation in the United Nations climate summits and resolved to fully engage in them," said Andrus. "At the level of us as Episcopalians, and in our congregations, institutions and dioceses, we began the beautiful, big commitment to daily choices leading to sustainable lives. It is possible that the Episcopal Church is the first denomination to join the partnership of businesses, cities, states, regions, faith bodies and tribes working together to keep the United States' commitment to the Paris Agreement," Andrus said.

Resolution <u>C049</u> encourages churches to serve and promote locally grown food. <u>B027</u> introduced gender inclusivity in climate change action. <u>A213</u> promotes energy and water efficiency across the church. <u>B025</u> urges the church to learn about regional watersheds and aquifers, recognizes water as a publicly held natural system and access to water and sanitation as a human right. <u>C063</u> advocates for ocean health through public policy advocacy, for example "to prevent or limit adverse effects to species and ecosystems from offshore oil, gas, and mineral exploration, drilling, and extraction and to support sustainable fisheries" and "to prevent illegal fishing, over-fishing, and by-catch." <u>D081</u> helps communities affected by change in energy use as they transition to clean energy economies. And <u>D053</u> encourages stewardship of creation with church-owned land.

"[What] these resolutions are helpful for is, that while we do live on the frontline of creation, we do have a lot of variety in the sorts of parishes and property that we use," said Alaska Bishop Mark Lattime, who served as the committee's secretary.

"I've got churches in our urban areas that have been asking about what kind of support we can get so that we can perhaps change some of our properties, how we could be more energy efficient, how we can be more active in reducing greenhouse gases, and I think the resolutions that we adopted and looked at this year will help to provide those resources, as well."

Energy companies view the <u>Arctic National Wildlife Refuge</u>, particularly its 1.5 million-acre coastal plain, as a potential oil and natural gas bonanza. This conflict has fueled for more than <u>30 years</u> a contentious debate over whether this coastal plain should be opened to oil drilling or kept as unspoiled habitat.

In December 2017, the Trump administration and congressional Republicans <u>opened</u> the refuge to oil exploration. In April this year, a <u>first</u> step was taken toward allowing drilling.

"Finally, <u>A068</u> called for eventual liturgical revisions to the Book of Common Prayer "that incorporate and express understanding, appreciation, and care of God's creation."

During convention, the Diocese of California launched a <u>web-based carbon tracker</u> for the Episcopal Church intended to support personal and communal choices. The fully functional carbon tracker will be available to U.S.-based diocese of the Episcopal Church by spring 2019 and the rest of the church by the fall.

When the bishop entered me into the ordination process for the priesthood two years ago, after 28-plus years of ordained ministry as a deacon, one of the first questions I was asked was, "What will we call you when you are ordained a priest?" My quick response was, "Well, Mother Bird has a nice ring to it!" My response was quick, because when someone suggested many years ago that I should be a priest, I thought, not with my name! (I wonder if there has ever been a male priest with the last name of Time?)

Since I have now been asked the what we will call you question multiple times in the last few weeks, and the ordination to the priesthood has taken place, I guess it is worth answering seriously at this point. There is a woman priest in the Episcopal church who goes by "Father" and states a couple of reasons for doing so: (1) She notes that it has been a traditional title for a priest and (2) she finds it is a great conversation starter. However, it doesn't feel quite right to me, especially since I don't have long pretty hair like she does; my using "Father" might confuse someone looking up at me from a hospital bed, under the influence of the latest pharmaceuticals that the medical profession has to offer. I know some women priests have used "Pastor" and others have used nothing; neither of these seem the appropriate choice, either. Proper English does not, by the way, allow "Reverend" as a proper spoken title in directly addressing someone. It is always meant to have "The" in front of it and is therefore used as a written title or in speaking about someone, such as "The Reverend Jane Doe is the most wonderful preacher!" You would not say "Rev. Doe, you gave a really meaningful sermon Sunday." (Mo. Doe sounds almost as amusing as Mo. Bird, doesn't it? Is there a Fr. Time in the church?)

Never mind. Back to the original question, what to call me. Simply Mother Virginia, abbreviated Mo. Some women priests do use Mthr. instead of Mo., I have noticed; but I will use Mo. (perhaps that says something about my age and my failure to text or something). Oh, by the way, don't err by calling me 'Mother Superior'...although maybe with a small "s"...just kidding. (It's late.)
